Carteret Borough and the New Jersey Department of Transportation (NJDOT) are committed to developing safety improvements that best balance pedestrian needs, the environment, community concerns and costs. We will hold a Public Information Center (PIC) to provide residents with information about the Carteret Pedestrian and Cyclist Waterfront Access Project. You are encouraged to participate and provide comments.

The Meeting:

The PIC will be an “open house” running from 4:00 to 6:00 PM on Tuesday November 29, 2022. At the meeting you will have the opportunity to review displays, ask questions and submit comments. You may also use the online survey form on the Carteret Borough website at any time up to the close of the comment period. Property owners with rental units are advised that tenants are also invited and encouraged to participate.

Waterfront Access Improvements:

Carteret Borough is in the process of reclaiming and revitalizing portions of the Arthur Kill waterfront where existing facilities include Waterfront Park, a fishing pier, marina, and waterfront fitness trail. Numerous additional waterfront improvements, are in the planning, design or construction phases which include:

- Ferry Terminal, Transit Village Access Road
- Southern and northern extensions of the Waterfront Walkway
- Carteret Avenue Extension & Roosevelt Avenue improvements
- Port Carteret Drive improvements

The goal of this project is to improve the Borough’s transportation infrastructure to connect pedestrians and cyclists with the Borough’s waterfront parks/piers/marina and

planned commuter ferry / transit village. Proposed improvements will include:

- New crossings and continuous sidewalk along Middlesex Avenue / Sica Industrial Highway
- ADA improvements
- Street appurtenances such as a bike rack, trash receptacles and benches

Estimated Schedule:

Final Design is expected to extend through 2023 and construction is anticipated to be completed in late Fall 2024.

Construction Cost:

Costs for Construction and Construction Inspection are expected to exceed \$500,000 which will be reimbursed through the Federal TAP, administered through NJDOT Local Aid.
